Any person or business which intends to sell tobacco products or tobacco paraphernalia on a retail basis must obtain and maintain a tobacco retailer permit.

"Tobacco product" means any of the following:

a. A product containing, made, or derived from tobacco or nicotine that is intended for human consumption, whether smoked, heated, chewed, absorbed, dissolved, inhaled, snorted, sniffed, or ingested by any other means, including, but not limited to, cigarettes, cigars, little cigars, chewing tobacco, pipe tobacco, snuff, and blunt wraps.

b. An electronic device that delivers nicotine, other substances or other vaporized liquids to the person inhaling from the device, including, but not limited to, an electronic cigarette, electronic cigar, electronic pipe, or electronic hookah.

c. Any component, part, or accessory of a tobacco product, whether or not sold separately. d. Exception. "Tobacco Product" does not include drugs, devices or combination of products that has been approved by the United States Food and Drug Administration for sale as a tobacco cessation product or for other therapeutic purposes where the product is marketed and sold solely for such an approved purpose. "Tobacco paraphernalia" means cigarette papers or wrappers, blunt wraps, pipes, holders of smoking materials of all types, cigarette rolling machines, e-cigarette liquid pods and any other item designed primarily for the smoking or ingestion of tobacco products. (See Cal. Business and Professions Code §22962.) https://leginfo.legislature.ca.gov

The sale of tobacco products and tobacco paraphernalia is governed by Pleasanton Municipal Code Chapter 9.32, http://gcode.us/codes/pleasanton which includes, but is not limited to, the following restrictions:

- Prohibition on the sale of flavored tobacco products citywide
- Prohibition on the sale of electronic smoking devices and related paraphernalia citywide
- Minimum package sizes and pricing
- > No new tobacco retail sales sites within 1,000 feet of public schools, parks or recreation facilities
